ARTICLES OF INCORPORATION

We, the undersigned persons, residents of the State of Florida end of the United States, do hereby associate ourselves together for the purposes of forming a for-profit corporation pursuant to Chapter 607, of the Florida Statues //and adopt(s) the following articles of incorporation for such corporation.
