**ARTICLE I

COMMENCEMENT OF CORPORATE EXISTENCE

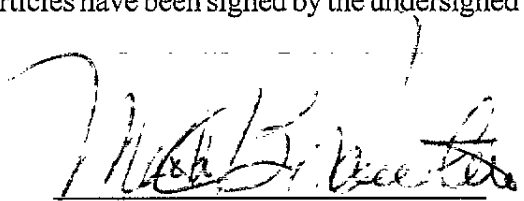

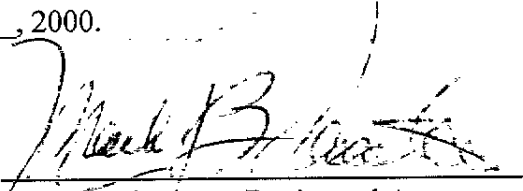
