5. OTHER PROVISIONS:

Indemnification:

The corporation shall indemnify each director, officer, employee and agent of the corporation, from liability at any time incurred as a direct or indirect result of, or in the course of, that party's position with the corporation or that party's direct or indirect service to the corporation in such capacity, in any such event, to the fullest extent that is permitted under applicable law.
