ARTICLES OF INCORPORATION LEGAL NURSE CONSULTANTS OF NORTHEAST FLORIDA, II

SECRETE AMILOS The undersigned incorporator to these Articles of Incorporation, a natural person to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is: LEGAL NURSE CONSULTANTS OF NORTHEAST FLORIDA, INC.

ARTICLE II

The initial business address of the principal office of this corporation in the State of Florida is 2814 Ravines Road, Middleburg, Florida, 32068. The initial mailing address of the principal office of this corporation in the State of Florida is P.O. Box 2217, Middleburg, Florida, 32050-2217. The Board of Directors from time to time may move the principal office to any other address in Florida.

ARTICLE III

The general nature of the business to be transacted by this corporation is:

To engage in activity or business permitted under the laws of the United States of America and the State of Florida.

To the same extent as natural persons might or could do, to purchase or otherwise acquire, and to hold, own, maintain, work, develop, sell, lease, exchange, hire, convey, mortgage or otherwise to dispose of and deal in, lands, leaseholds, and any interest, estate, and rights of real property, and any personal or mixed property, and any franchises, rights, licenses or privileges necessary, convenient or appropriate for any of the purpose herein expressed.

To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise to dispose of, and to invest in, deal in and with goods, wares, merchandise, real and personal property, and services of every class, kind and description, now or hereafter permitted by law.

To conduct business in, have one or more offices in and to buy, hold, mortgage, sell, convey, lease, or otherwise to dispose of real and personal property, including franchises, patents, copyrights, trademarks and licenses, in the State of Florida, and in all other states.

To contract debts and borrow money, issue and sell pledge bonds, debentures, notes and other evidences of indebtedness, and to execute such mortgages, transfers of corporate indebtedness as required.

To purchase corporate assets of any other corporation and engage in the same or other character of business.

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of shares of capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida, or any other state, and while owner of such stock to exercise all rights, powers and privileges of ownership, including the right to vote such stock.
