THE UNDERSIGNED, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is: SOUTH FLORIDA TRAFFIC SCHOOL, INC.

ARTICLE II

This Corporation shall have perpetual existence.
