The general nature of the business to be transacted by this corporation is:

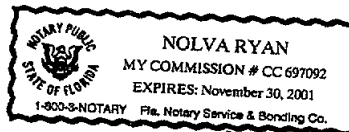

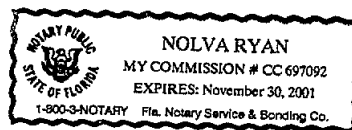
