**ARTICLE I - CORPORATE NAME**

THE NAME OF THE CORPORATION IS COLDECON CORP.

**ARTICLE II - DURATION**

**ARTICLE III - PURPOSE**

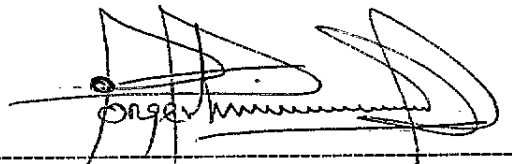

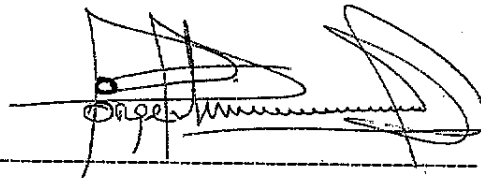
