ARTICLES OF INCORPORATION OF Know Clean, inc.

ARTICLE I - NAME
The name of this Corporation shall be:
Know Clean, Inc.

ARTICLE II - DURATION
This Corporation shall have perpetual existence commencing on 03/10/00

ARTICLE III - PURPOSE
