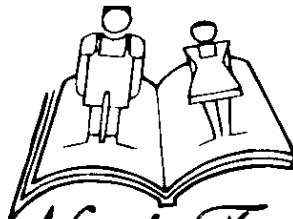

Sometime in June I received a letter from your office requesting that I resend my UBR with the name of the Registered Agent. I sent it back to your office in July with the name Charles C. Scott, II and also indicated that he was the agent from the previous years.

I called your office in August or September to find out how to get a copy of my registration certificate as I had misplaced the original and was told to send \$8.75 and I would receive a copy in the mail. When I spoke with the representative in your office she never indicated that my original UBR had not been received. As a matter of fact, she acknowledged that it had been received.

I am sending back to you a copy of my UBR and I don't have the letter because I was asked to mail it back to your office with the additional information on the UBR. I found out that my company was listed inactive when I went to open a new checking account and was told that my business was listed as inactive.
