**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of **YOURIGLOO.COM, INC.** pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is:

YOURIGLOO.COM, INC.

ARTICLE II. ADDRESS

The principal place of business and mailing address of the corporation shall be 2499 Glades Road, Suite 103, Boca Raton, FL 33431.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation with the Florida Department of State.

ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES
