

ARTICLE I - NAME

The name of this corporation is NUTOOL ENGINEERING, INC.

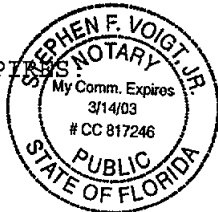
