# ARTICLES OF INCORPORATION OF PANZER-YONGUE & ASSOCIATES, INC.

## ARTICLE I

### Name

The name of this Corporation is PANZER-YONGUE & ASSOCIATES, INC.

## ARTICLE II

### Principal Office

The principal office of this corporation shall be 9153 Woodjack Court, Jacksonville, Florida 32256.

## ARTICLE III

### Duration

This corporation shall have perpetual existence.

## ARTICLE IV

### Purposes and Powers

The nature and purposes of the business to be carried on by PANZER-YONGUE & ASSOCIATES, INC. are to engage in health care market management and in any activity or business permitted under the laws of the United States and of the State of Florida.
