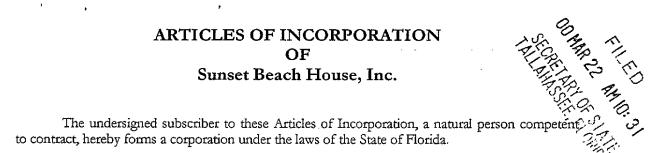

ARTICLES OF INCORPORATION **OF**

Sunset Beach House, Inc.



ARTICLE I Name of Corporation

The name of the corporation shall be:

Sunset Beach House, Inc.

ARTICLE II Nature of Business

The general nature of the business to be transacted by this corporation is anything related to motel operation or any other activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE III Capital Stock

The maximum number of shares the corporation is authorized to have outstanding at any one time is 1,000 shares of One (\$1.00) Dollar par value, all of which shall have the same rights and privileges.

ARTICLE IV... Initial Capital

The amount of capital with which this corporation will begin business is not less than One Thousand (\$1,000.00) Dollars.

ARTICLE V Term of Existence

This corporation is to exist perpetually.

ARTICLE VI Principal Place of Business
