**ARTICLES OF INCORPORATION
of

THE UNDERSIGNED, acting as the sole incorporator of **CEREBUS CONSULTING, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation of **CEREBUS CONSULTING, INC.** for such corporation:

ARTICLE I

Name and Address

The name of the corporation shall be **CEREBUS CONSULTING, INC.**, and its principal corporate address shall be initially located at 2704 Rew Circle, Suite 105, Ocoee, FL 34761.

ARTICLE II

Duration

This corporation shall have perpetual existence unless sooner dissolved according to law, and shall commence its corporate existence upon the filing of these Articles.

ARTICLE III

General Purposes

This corporation is organized for the purpose of transacting, conducting, carrying on, operating, and engaging in any activity or business permitted under the laws of the State of Florida, and the United States.

ARTICLE IV

Shares

The aggregate number of shares which the corporation shall have authority to issue is One Hundred Million (100,000,000), consisting of Ninety Million (90,000,000) shares of common stock, \$.001 par value per share and Ten Million (10,000,000) shares of "blank check" preferred, no par value.

Action By Consent


The directors and shareholders of this corporation may take action by written consent as provided by law.
