ARTICLES OF INCORPORATION

Nova Technology of Florida, Inc. Incorporation, a natural person competent to contract, hereby forms a for profit corporation organized under the laws of the State of reno la consequencia de la compansión de l Florida.

<u>Article I. Name</u>

The name of the corporation shall be Nova Technology of Florida, Inc. The initial principal place of business and the mailing address of this corporation shall be 801 Brickell Avenue., 9th Floor, Miami, Florida 33131.

Article II. Term of Existence

This corporation shall be deemed to have a perpetual existence and shall further be deemed to have commenced its corporate existence on the date of the filing of these Articles of Incorporation.

The corporation shall have the following powers:

- c. To have a corporate seal, which may be altered at pleasure, and to use the same by causing it or a facsimile thereof to be impressed, affixed or in any other manner reproduced;
