**ARTICLES OF INCORPORATION  
OF  
NATIONAL ASSOCIATION OF FINANCIAL ADVISORS, INC.**

1. The name shall be National Association of Financial Advisors, and the initial address of its principal office shall be c/o Robert D. Ross, 7071 Rain Forest Drive, Boca Raton, Florida 33434.
2. The purpose for which this corporation is organized shall be the transaction of any and all lawful business for which corporations may be incorporated, pursuant to Chapter 607 of the Florida Statutes, as amended, revised, or restated from time to time.
3. The aggregate number of authorized Capital Stock of this corporation shall consist of 1000 shares of Common Stock having a par value of \$.10 per share.
4. The amount of Capital Stock with which the corporation shall have a perpetual existence.
5. The amount of Capital Stock with which the corporation shall begin business shall not be less than \$500.
6. The Board of Directors shall be composed of one or more persons.
7. Robert D. Ross, 7071 Rain Forest Drive, Boca Raton, Florida 33434, is the name and/or address of:
  - (a) the person who is incorporating the corporation;
  - (b) the first member of the Board of Directors, who, unless otherwise provided by the By-Laws, shall hold office for the first year of the existence of the corporation, or until his successor or successors are elected or appointed and have qualified; and
  - (c) the registered agent and registered officer designated to accept service of process within this State pursuant to Florida Statutes, Chapter 48.091, who hereby accepts to act in the capacity and agrees to comply with provisions of said Act relative to keeping said office.
