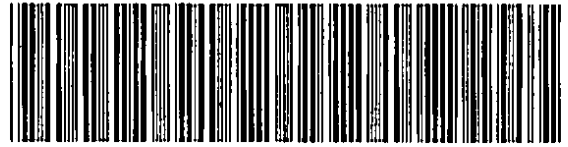

(Name Change)

Alvarez, Winthrop, Thompson & Storey, P.A., a Florida professional association (the "**Professional Association**"), by and through its President hereby adopts this Amendment (Seventh) to its Articles of Incorporation of March 28, 2000, as previously amended (the "**Articles of Incorporation**"), as hereinafter set forth.
