ARTICLES OF INCORPORATION
OF

I, the undersigned, hereby make, subscribe, acknowledged and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a professional association for profit in accordance with the laws of the State of the State of Florida.

ARTICLE I
NAME

Existence of Corporation

This corporation shall have perpetual existence.

ARTICLE IV
Purposes

The general nature of the business to be transacted by this corporation or the objects or purpose of the corporation shall be as follows:

(a) To engage in the business of providing quality African music and movies etc compact disc, audio and video tapes.

(b) In general, to have and exercise all powers conferred by the corporation may engage in the transaction of any or all-lawful business for which corporations may be incorporated under the laws of the State of Florida.

(a) The total number of shares of capital stock authorized to be issued by the corporation shall be 10,000 shares having a par value of \$1.00 per share. (b) The initial board of directors shall be appointed by a select committee and shall serve voluntarily.
