

**ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a Florida Corporation under the Florida General Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

**ARTICLE I
NAME**

The name of the corporation **HARBOUR POINTE OF PENSACOLA, INC.**, and the principal place of business and mailing address is 8608 Eight Mile Creek Road, Pensacola, Florida 32526.

**ARTICLE II
PURPOSE**

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

**ARTICLE III
CAPITAL STOCK**

The Corporation is authorized to issue One Thousand (1000) shares of One Cent (\$0.01) par value common stock.

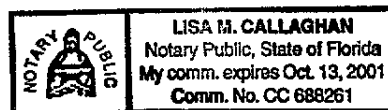


