**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF

1. The name of the Corporation is Yam International Communications Inc., document number P00000031363.
2. The following provision of the Articles of Incorporation of the Corporation is amended in the following particular:

Article I is deleted and replaced with the following:

**ARTICLE I
NAME**


The name of the Corporation is **YAM WIRELESS, INC.**
