ARTICLES OF INCORPORATION
FOR PROFESSIONAL CORPORATION
FOR

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

Ty Trudeau, D.C., P.A.

The undersigned natural person(s), competent and licensed to practice in the state of Florida, acting hereby as Incorporator(s) for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607, Florida General Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I- NAME

The name of this corporation shall be Ty Trudeau, D.C., P.A.

ARTICLE II-PURPOSES

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

To engage in every aspect in the fields for which the shareholders are licensed. The specific purpose of the corporation is to perform medical services.

To engage and render the professional services involved only through its officers, agents and employees who shall be duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation.

It is intended that this corporation is organized for and may also conduct and transact any or all lawful business authorized and not prohibited by Chapter 607, Florida Statutes, as the same may be from time to time amended.

ARTICLE III-DURATION

The Corporation shall exist perpetually commencing such existence upon the filing of these Articles.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is One Hundred Thousand (100,000) shares of common stock having no par value per share.

ARTICLE V - PRINCIPAL OFFICE, INITIAL REGISTERED OFFICE AND
REGISTERED AGENT

The principal office of the corporation shall be at 500 Rachna Lane #D, Kissimmee, Fl. 34741. The initial street address of the registered office of this corporation in the State of Florida will be (physical) 500 Rachna Lane #D, Kissimmee, Fl. 34741 and (mailing) 500 Rachna Lane #D, Kissimmee, Fl. 34741. The Board of Directors may from time to time move the registered office to any other address in Florida. The name of the initial registered agent of this corporation at that address is Ty Trudeau. The Board of Directors may from time to time designate a new registered agent.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

- A. The initial number of Directors of this corporation shall be one.
- B. The number of Directors may be increased or diminished from time to time by the By-laws adopted by the shareholders, but shall never be less than one.
- C. The name and street address of the initial member(s) of the Board of Directors, who shall hold office for the first year of existence of this corporation or until their successors are elected or appointed and have qualified are:

The corporation shall indemnify any registered agent, officer, director or incorporator, or any former registered agent, officer or director, to the full extent permitted by law.

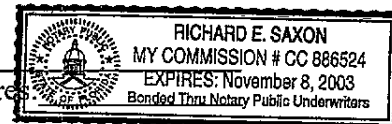


