PURSUANT TO SECTION 607.0124 OF THE FLORIDA BUSINESS CORPORATION ACT
THE UNDERSIGNED CORPORATION ADOPTS THESE ARTICLES OF CORRECTION

FIRST: The name of the corporation is Cyber-Care Ventures Corp. I.

SECOND: The document to be corrected is the Articles of Incorporation, which was filed on
