



The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

SEA ISLAND PROPERTIES, INC.

The principal place of business of this corporation shall be 4000 Oceanshore Blvd. Ormond Beach, Florida 32176, and the mailing address shall be P. O. Box 1446, Flagler Beach, Florida 32136.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK






