# ARTICLES OF INCORPORATION OF

### WIRELESS & CABLE COMMUNICATIONS GROUP, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I NAME

The name of the corporation is WIRELESS & CABLE COMMUNICATIONS GROUP, INC. (hereinafter called the "Corporation").

# ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS
