ARTICLES OF INCORPORATION OF RESTORATION SYSTEMS, INC.

The undersigned acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I - NAME

The name of the corporation is Restoration Systems, Inc.
