The undersigned, being duly licensed to practice chiropractic medicine in the State of Florida, desires to form a professional corporation in accordance with Chapter 607 and Chapter 621 of the Florida Statutes and the Florida Professional Service Corporation Act, and adopts the following Articles of Incorporation:

#### ARTICLE I. NAME
