

ARTICLES OF INCORPORATION
OF
EAST BOCA PLAZA ASSOCIATES, INC.

ARTICLE I

The name of the corporation is EAST BOCA PLAZA ASSOCIATES, INC. (hereafter the Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation is 3612 W. HILLSBORO BOULEVARD, DEERFIELD BEACH, FLORIDA 33442.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

ARTICLE IV

The Corporation shall hold a special meeting of shareholders only:

1. On call of the board of directors or persons authorized to do so by the Corporation's bylaws; or



This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by any law in existence either now or hereafter.


