CERTIFICATE OF INCORPORATION

SECRETARIAN PARTIES PA For the purpose of forming a corporation for profit under the general incorporation laws of the State of Florida, it is respectfully requested of the Secretary of State the approval of such incorporation under the following Articles.

ARTICLE 1
