ARTICLES OF INCORPORATION OF BLUE MAX & COMPANY, INC.



The undersigned, acting as Sole Incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation:

ARTICLE I
