ARTICLES OF INCORPORATION FOR TOWN DIGEST, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation is TOWN DIGEST, INC.

ARTICLE II NATURE OF BUSINESS

The corporation shall be engaged in the business of web design, operation and maintenance of a community internet web site and/or any other lawful business permitted under the laws of the United States and the State of Florida.

ARTICLE IV DURATION

This corporation shall have perpetual existence.



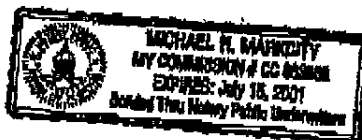
