ARTICLE I. NAME

The name of this corporation is **DAVIDSON AGENCY, INC.**

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing upon the filing of these Articles.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV. CAPITAL STOCK

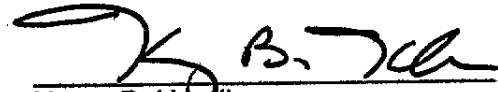
ARTICLE IX. INDEMNIFICATION
