ARTICLE I.

NAME OF CORPORATION

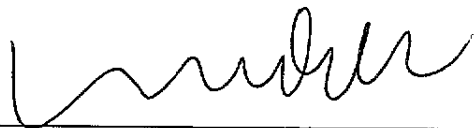
