#### ARTICLES OF INCORPORATION

#### OF

#### LCOMM, INCORPORATED

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

#### ARTICLE I

The name of the corporation is **LCOMM**, **INCORPORATED**, herein after referred to as the "corporation."
