The undersigned, acting as incorporator of this corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be RYAN J. CORPORATION.

ARTICLE II - TERM OF EXISTENCE

This corporation shall continue in existence for an indefinite term.

ARTICLE III - GENERAL PURPOSE

The general purposes for which this corporation is organized shall be:
