ARTICLES OF INCORPORATION
OF

SANDRA HEIST, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

SANDRA HEIST, INC.

The address of the principal office of this corporation shall be 8933 Lakes Boulevard, West Palm Beach, Florida 33412, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

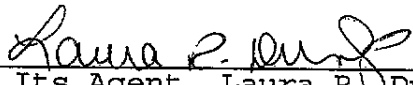
