of

## **VISIONA INC.**

The undersigned subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, hereby form a corporation under the laws of the State of Florida.

### ***ARTICLE I - CORPORATE NAME***

The name of the corporation shall be: **VISIONA INC.**

### ***ARTICLE II - DURATION***

This corporation shall exist perpetually unless dissolved according to Florida law.

### ***ARTICLE III - NATURE OF BUSINESS***

The corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the United States and the State of Florida.

And other lawful business and in general, to carry on any other legal business whatsoever which is calculated directly or indirectly to promote the interest of the corporation or to enhance the value of its properties. 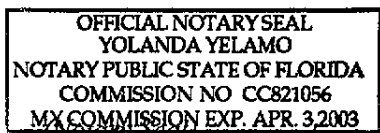
