Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is JWG ASSOCIATES, INC.
(the "Corporation"), Charter #P00000032488.

2. The following Amendment to the Articles of Incorporation was adopted by the written consent of the sole Incorporator of the Corporation as of March 30, 2000 in the manner prescribed by Section 607.1005 of the Act. This amendment was adopted without shareholder action; this shareholder action is not required by the Florida Business Corporation Act.

3. Article I of the Corporation's Articles of Incorporation is hereby deleted and replaced by a new Article I, as follows:

"ARTICLE I

The name of the Corporation is Velocidad Internet, Inc."

4. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.

5. The effective date of this amendment shall be upon the filing of these Articles of Amendment.
