ARTICLES OF INCORPORATION

The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLES I: NAME OF THE CORPORATION

The name of the corporation is LEOMARS, INC., hereinafter referred to as the "Corporation".

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office and the mailing address of the Corporation is 8965 SW 177th Terrace, Miami, FL 33157.

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

ARTICLE VII: INITIAL REGISTERED OFFICE AND REGISTERED AGENT
