

The name of this corporation is PIPE PLUG U.S.A., INC.

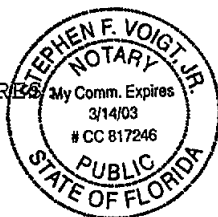
