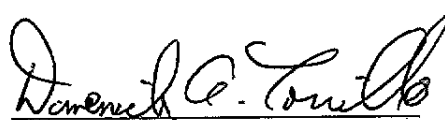
ARTICLE VI – AMENDMENT

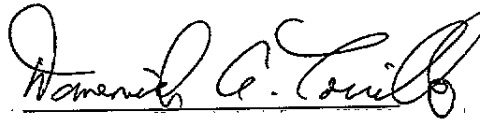
