The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

**Article I - Name**

The name of this Corporation is **8504 SUITE P, INC.**

**Article II - Principal Place of Business**




