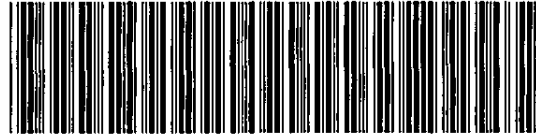

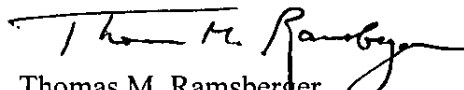

TO THE ARTICLES OF INCORPORATION

White Technologies, Inc., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), in order to amend its Articles of Incorporation as now in effect (the "Articles of Incorporation"), in accordance with the requirements of Section 607.1006, Florida Statutes, does hereby certify as follows:

1. The name of the Corporation is White Technologies, Inc., and its Document Number with the Florida Department of State is P00000032894.

2. The amendment being effected hereby (the "Amendment") was duly adopted and approved by the Directors of the Corporation by written consent on April 30, 2008, and proposed by the Directors to the Shareholders of the Corporation in such written consent. The Amendment was duly adopted and approved by the Shareholders of the Corporation by written consent on April 30, 2008 by unanimous vote of the Shareholders which was sufficient for approval.

Article I - Name and Address

The name of the corporation is **BlueFlame Consulting, Inc.** and the mailing and street address of the corporation shall be **2811 Sandpiper Place, Clearwater, FL 33762.**

5. The Articles of Incorporation are hereby amended by deleting Article VI thereof, and in its place and stead substituting the following:

Article VI - Registered Office and Agent

The registered office of this corporation shall be located at **2811 Sandpiper Place, Clearwater, Florida 33762**, and the registered agent of this corporation at such office shall be **Edward Ameen**. This corporation shall have the right to change such registered office and such registered agent from time to time, as provided by law.
