Pursuant to the provisions of Section 607.1006, <u>Florida Statutes</u>, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** Amendment Adopted: **ARTICLE V** is hereby amended to read as follows:

## ARTICLE V: CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is one million (1,000,000) shares having a par value of \$1.00 per share.
