I represent Lasata Corporation and its sole officer and shareholder, Mr. Ronald D. Merritt. I am writing to request waiver of the penalties for the untimely filing of the 2001 and 2002 Uniform Business Reports ("UBR") for the aforementioned corporation. Enclosed are executed 2001 and 2002 UBR's and a check for the \$300.00 fee for the annual report fees for 2001 and 2002.

The basis for my client's request for a waiver of penalties is as follows. My client never received the 2001 or 2002 UBR's. He changed the principal mailing address of the corporation before the May 1, 2001 deadline and arranged for the mail to be forwarded. For unknown reasons, the 2001 UBR was not forwarded. Nor did Mr. Merritt receive the 2002 UBR.

Mr. Merritt is not a long time resident of Florida and was not familiar with corporation law. He was unaware of the deadline for the filing of the annual report by the corporation. Mr. Merritt only discovered after May 1, 2002 that the corporation had been dissolved when he was so advised by his accountant who was preparing the corporate tax return. As a result, Mr. Merritt retained by services to intercede on the corporation's behalf.

Based upon the foregoing and my client's good faith, we request that all penalties be waived.
