**ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of this corporation is ZOZZO IS IN THE HOUSE, INC whose principal address is 1623 N.E. 8 Ave. Apt. 4, Ft. Lauderdale, Florida 33305

ARTICLE II


