The name of the corporation is **GAILBOORD AND ASSOCIATES, INC.** The principal address of the corporation is: 2558 GARDEN COURT COOPER CITY, FLORIDA 33026-3657.

The period of its duration is perpetual.


ARTICLE EIGHT
