**ARTICLES OF INCORPORATION  
OF

I, the undersigned Incorporator, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation is:

**JUDGMENT RECOVERY SERVICES, INC.**

The Principle place of business of this corporation shall be 287 Woodbury Pines Circle, Orlando, Florida 32828.

**ARTICLE II**

This Corporation is organized for the purpose of engaging in the collection of judgments and to engage in any activity permitted under the laws of the United States and the laws of the State of Florida.

The Corporation shall do everything necessary and proper in accomplishing the purposes set forth above and to do anything incidental thereto which is not forbidden under the laws of the United States and the State of Florida.

**ARTICLE III**

The maximum number of shares of stock that this Corporation is authorized to have outstanding at ant time is 1,000 shares of common stock having a nominal or par value of \$1.00 per share. Shares of the Corporation's stock shall be issued only in compliance with subchapter S of the Internal Revenue Code regarding corporations.

**ARTICLE IV**

The Corporation shall have a perpetual existence.

#### ARTICLE V

The corporation shall indemnify any officer or director or any former officer or director, to the full extent of the law.


ARTICLE X




