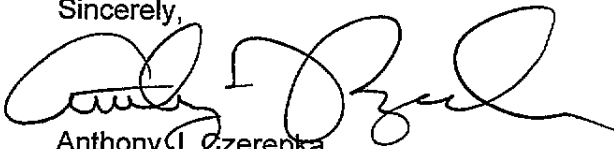

INITIAL CAPITAL

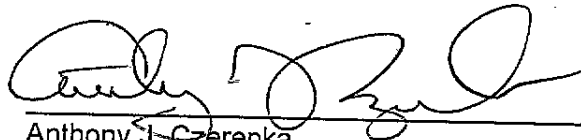
The amount of the capital with which the corporation shall begin business is Five Thousand (\$5,000.00) dollars.
