# ARTICLES OF INCORPORATION

Donald Gelin, P.A.

The undersigned, desiring to form a professional corporation in accordance with Florida Statute for the practice of law, do hereby adopt the following Articles of incorporation.

## ARTICLE I NAME

The name of the corporation shall be as follows:  
Donald Gelin, P.A.

## ARTICLE II PURPOSE

The purpose for which the corporation is organized are as follows:

1. Primarily to engage in the specific business of the practice of law as a professional law corporation and to carry on services incidental thereto. The practice of law is the sole and exclusive professional service to be rendered by this corporation.
2. To engage generally in the business of a law corporation as the same is now or hereafter defined by statute, rule and regulation, and in connection therewith to own property, to enter into contracts, and to transact any lawful business related thereto;
3. The professional services of this corporation shall be carried out only through officers, employees, and agents, each of whom has been admitted to the bar of, and is duly authorized to practice law in, the State of Florida.
4. Each stockholder in the corporation, and each attorney employed by the corporation, shall practice law subject to the authority and power of the Supreme Court of the State of Florida to regulate such practice, and each such person shall at all times remain subject to reprimand or discipline for his conduct as an attorney.
