ARTICLE I - NAME

The name of this Corporation is: **BAKER NETWORK TECHNOLOGY CORP.**

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

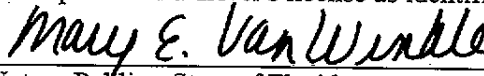

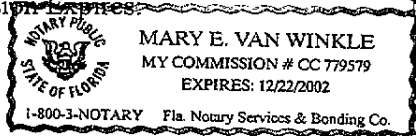

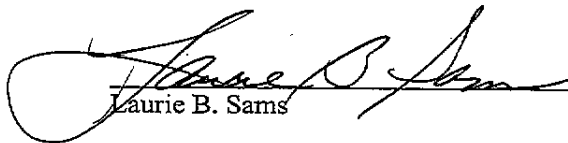
